To see the number of new members we need in order to fund our modest budget for 2008, look at the small set of numbers to the left of the amended budget column. We need 150 renewals (from 152 annual members—an impossible rate of retention) this year. So far we have about 80. We need 75 new annual members and we have about 50. We need 50

Life Memberships and we've only gotten 7.

We have trimmed our Gifts, Grants and Scholarships budget by \$1,000 from last year. Generous support of our Scholarship Fund through donations big and small along with the purchase of Alumni products allows us to continue giving four \$1,000 scholarships to seniors this year. Unfortunately, we did have to reduce the amount we donate to the AISD Education Foundation (see page 2) from \$3,000 to \$2,000. That leaves \$100 in the Gifts budget to donate to AHS in some other area.

Three years ago, the Colt Football Booster Club asked us to help them purchase the inflatable run-through so popular at high school games these days. Fortunately, we had a rush of annual members upgrading to life memberships that year and we had the cash on hand to help them buy it. No such luck for any requests this year.

AHS History Corrections: Mark Richardson, '79, writes "giving 1985 as birth year of the logo with the sideways horseshoe representing the letter 'C' in Colts is inaccurate. That logo was in use by the football team in 1977 appearing on the Super Colt t-shirt—an award to football players for special effort. The slogan 'How Sweet It Is to Be in Colt Country' was first used by Principal James Crouch at an outdoor pep rally in 1978. Students then thought it silly and I remember one who would show up at a pep rally, dressed in a suit and proclaiming How Sweet it is... We were so surprised the slogan stuck. Since Mr. Crouch was such a great principal, leader and friend, I'm sure his quote lived on, quite rightly, through the faculty and students who passed it on."
